VISA REQUIREMENTS PER TRAVELER

- **Your PASSPORT:** ensure you have six months remaining validity and blank visa pages.
- Two (2) completed and signed visa applications, photocopies are acceptable.
- Two (2) passport style (2x2) photos, black and white or color are acceptable.
- An INVITATION: for tourist visa, a tourist voucher from hotel in Azerbaijan that lists the hotel confirmation number. For business visa, an invitation letter from Host Company or Organization in Azerbaijan, authorized by the Azerbaijan Ministry of Foreign Affairs. Global Visa can assist with invitations if needed (see below).
- This completed order form with a money order payable to Global Visa Services (see TOTAL below)
