VISA ORDER FORM FOR KYRGYZSTAN

The following documents are required for each visa. Please send them to **Global Visa Services** using a mail service with tracking, such as Express Mail or Federal Express.

VISA REQUIREMENTS PER TRAVELER

- Your passport (US resident aliens must also submit copy of US visa or green card)
- One (1) completed and signed visa application – **MUST BE TYPED**
- Two (2) passport style (2"x2") photos - black and white or color are acceptable
- For stays longer than one month, or for multiple entry visas, an official invitation from the Kyrgyz Ministry of Foreign Affairs is required.
- **FOR BUSINESS VISA:** A business letter of responsibility is required, to be typewritten on your company letterhead and addressed to "Embassy of Kyrgyz Republic, Visa Section, Washington DC", stating: nature of business to be performed, name and address of reference to be visited, and guarantee of return transportation and sufficient funds for the visit. The letter should be signed by an officer of the company other than the applicant.
